The seminar proposes a meeting with urban social movements, activist research groups, NGO's, local authorities, who are working on urban issues.

This meeting will provide and the opportunity to share our experiences, in order to:

- encourage communication and partnership and to take concrete action (e.g. eviction-free areas, development
 of public housing service, participative urban planning), among the different urban stakeholders
- to support the Peoples' Europe (amendments to the Constitution of the European Union, viability of social rights, allocation of structural funds to social policies like housing, opposition to selling off communal property and public services (Bolkenstein Directive/GATT-WTO)
- promote the next steps with the aim of involving the different subjects (social organizations, researchers, NGO's and local authorities).

In this way urban social movements and inhabitants' associations, the local authorities and activist research groups would consolidate their positions as key players in issues regarding the urban conflicts linked to neo-liberal globalization, thus empowered to act singly or forge alliances, in order to obtain concrete results on behalf of the homeless and poorly housed people of Europe.
